Hi Kory,

A few weeks ago Dr. Masten, Pruden, Roy and I submitted questions to Henry Ford Medical System (HFMS) about IRB related to a 250 word paper, that reported results of an experiment in Flint that resulted in the deaths of 5/10 patients. We have submitted many questions to Dr. Marcus Zervos about this paper, which we consider alarmist, and further questioning how such a study could receive IRB approval.
