TO: Participants in EPANET class in Cincinnati

On behalf of Arnie Strasser and myself, your class instructors, we would like to welcome you to the EPANET class next week. By now you should have received a welcome email from the Urban Watersheds Research Institute with instructions on how to prepare for the class (see below for a copy of the instructions). The most important steps are that you download the EPANET software onto your computer and copy the input and data files to be used during the exercises onto your computer. I have found it easiest if you copy all of the input and related data files into a single folder and call it something like "EPANET input files". If you are having any problems accessing or using the google drive files described in the instruction letter, I have created a single zipped file containing all of the files needed for the exercises and attached them to this email. You simply need to create the folder described above and unzip the attached files into that folder.

If you have any problems or issues coping with the instructions, we will be happy to help you with this at the class. Alternatively, if you are impatient about this, feel free to contact Arnie or myself by email and we will try to help you remotely before the class via email. If you need help in Cincinnati, you may want to show up a little early for the class so we can help you resolve any problems. We are looking forward to meeting you and working with over the 2-day period.
